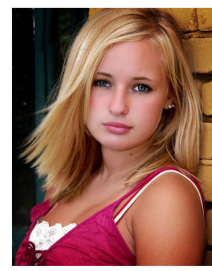

## Staley Wessel Photography Terms and Policies

### Standard Session:

The creative fee for a standard location session with Staley Wessel covers the photographer's time and talent only. This fee is **\$100** and must be paid to hold your desired date and time.

A-la-carte prints and products are purchased separately, please see detailed pricing attached.  
Discount packages at the end.

This fee is non-refundable but may be applied to a rescheduled session within 30 days (as available).  
Sessions may be rescheduled due to illness or injury.

To apply your creative fee to a rescheduled session you must contact Staley Wessel no less than 24 hours in advance of your scheduled time and the rescheduled session must take place within 30 days.  
No-shows forfeit this fee.

In the event of poor weather, outdoor sessions may reschedule or switch to an indoor location.

### The session includes:

A session of up to two hours either at your home or at a location of our choosing.  
Newborn sessions may take less time or more depending on the child.  
Multiple locations and clothing changes are allowed within that time frame.  
Travel within 20 miles of 64014 included. Outside this area please contact me for pricing.  
A session may include any combination of one immediate or nuclear family.

### Session gallery:

Once your session is complete I will hand pick around 20 images for your gallery.  
These images are carefully enhanced to bring out their best.  
All gallery images will have basic enhancements and a few artist picks will have full enhancements.  
Upon placing your order ALL of your ordered images will have full enhancements.  
This process may take from seven days to two weeks.  
You will be notified by phone and or email when your on line slide show gallery is available for viewing.  
The gallery expires seven days from opening.  
There is a \$50 fee to republish the gallery after expiration.  
The entire gallery is available to republish for 60 days after the session date.  
After 60 days images ordered or kept for portfolio use will be archived for one year.  
Other images may be purged.  
Because all prices are subject to change, prices at the time of ordering apply to all orders placed for archived images.  
Prices at the time of the session are honored for 60 days.  
**Session fees do not include images in print or digital form.**

**Payment and delivery:**

Payment is due upon ordering via cash, check, or credit card (accepted on line through paypal).

There is a \$30 fee for returned checks.

Please allow 2-3 weeks for delivery of prints. Rush orders may be possible upon request.

Please allow 4-6 weeks for delivery of specialty items.

**Copyright:**

All images are the property of Staley Wessel and are protected under federal copyright laws.

Copying images without permission is punishable by law with fines of up to \$150,000 per image.

It is against the law to copy, print, scan, email, download or otherwise reproduce these images in any way without permission.

Staley Wessel retains the right to all images for commercial and competitive use.

### A-la-carte Pricing:

A-la-carte pricing requires a \$250 minimum order.

#### Digital image files:

Full resolution digital image files are delivered on CD with print release for personal use as well as print recommendations. Also includes matching web resolution files and matching 4x6 prints. Minimum order of 3 files required. Priced on a sliding scale.

- 3 – 5 files ~ \$50 each
- 6 – 9 files ~ \$45 each
- 10-14 files ~\$40 each
- 15 or more files ~\$35 each

#### Deluxe Prints:

Deluxe prints are created on the highest quality photographic paper and with the exception of wallet prints, all are coated for protection and longevity.

All wall prints are custom cropped and mounted on styrene for durability and come ready for framing.

All prints are available on our beautiful pearl paper for an additional 25% (this paper does not receive the coating because that would take away from it's beauty)
